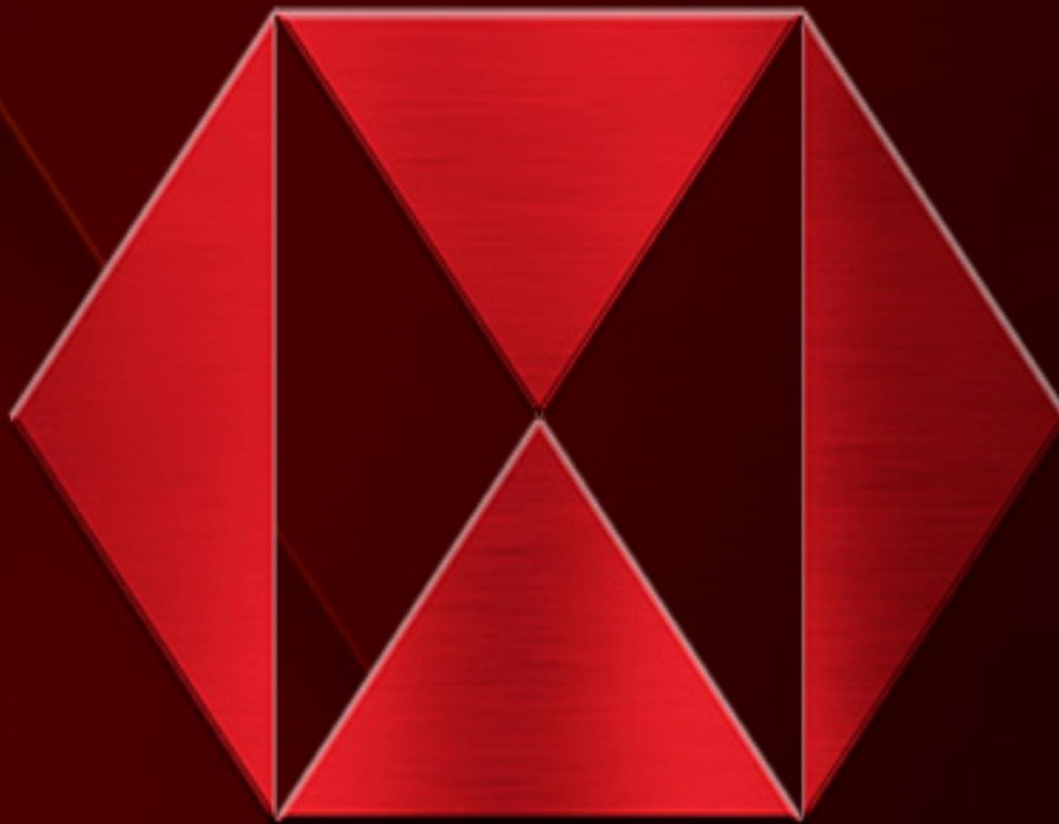

Glossary

Coupon type: Some notes/ bonds may have variable or floating coupon rate terms. For details, please contact your dedicated HSBC Premier Elite Director or Relationship Manager.

Coupon frequency: Coupon frequency refers to how often coupon will be paid.

A = Annual / At maturity

S/A = Semi-annual

Q = Quarterly

M = Monthly

Credit rating (S&P / Moody's): Credit ratings are provided by credit rating agencies to assess the financial strength of the bond issuer/ guarantor being able to meet its financial obligations for investors. Bonds with credit rating of BB/ Ba or below are considered as "Non-investment grade bonds" / "High Yield bonds".

Offer Yield to Maturity (YTM): The indicative annual rate of return on purchasing a bond on the last update date, assuming it is held until maturity.

Professional Investor (PI): Individual investor who satisfies the requirements of the Securities and Futures (Professional Investor) Rules (Cap 571D) ("PI Rules").

Risk Disclosure

- ◆ Bonds are mainly medium to long term fixed income products, not for short term speculation. You should be prepared to hold your funds in bonds for the full tenor; you could lose part or all of your principal if you choose to sell bonds prior to maturity

Additional risk for High Yield bonds
